

PRIVACY POLICY

Your privacy is important to us. We provide this notice to explain our online information practices and the choices you can make about the way your information is collected and used. This notice applies to all information collected or submitted through the Broad River Photography website and blog.

Email Policies

We are committed to keeping your email address confidential. We do not sell, rent, or lease our subscription lists to third parties, and will not disclose your email address to any third parties except as allowed in the section titled Disclosure of Your Information.

We will maintain the information you send via email in accordance with applicable federal law.

In compliance with the CAN-SPAM Act, all emails sent from our organization will clearly state who the e-mail is from and provide clear information on how to contact the sender. In addition, all email messages will also contain concise information on how to remove yourself from our mailing list so that you receive no further email communication from us.

Users who no longer wish to receive our newsletter or promotional materials may optout of receiving these communications by clicking on the unsubscribe link in the email.

Why We Collect Personal Information

We use the personal information collected from you to keep you informed about products and services, facilitate portrait sessions and/or wedding events, communicating with your regarding your session or event, sending updates via newsletter, and processing any transactions with Broad River Photography. Such personal information we collect is not used for any other purpose and is not shared.

We never use or share the personally identifiable information provided to us online in ways unrelated to the ones described above.

Broad River Photography uses the information that we receive or collect for the following general purposes: to provide updates to you regarding our products and services, to fulfill your requests for products and services, improve our products and services, contact you, conduct research, and to optimize and improve our website.

The only personal information we collect is name, email address, and telephone number. Your credit card information will also be collected if that form of payment is used to make your purchase, but that data is only used to process your transaction and is not stored in our database. When you purchase products or services, we collect additional information needed to complete the transaction such as your shipping address and other billing information.

Disclosure Of Your Information

Broad River Photography does not rent, sell, lease or share personal information about you with third parties. However, we may disclose your personal information to a third party, including a lawyer or collection agency, when necessary to enforce our terms of service or any other agreement between you and the Company.

Use Of Cookies

Broad River Photography does not currently use cookies or web beacons on our website.

Children Under The Age Of 13

Protecting the privacy of children is very important to Broad River Photography. For that reason, we never collect or maintain information from those we actually know are under the age of 13, and no part of our website is designed to attract anyone under the age of 13.
